#### Trustees' Report:

Trustee Boergadine reported there were 5 complaints this month, 4 for tall grass and overgrowth and one for a hole in the garage side. Violation letters sent. No sewer lateral issue reported.

Trustee Hollander reported 2 streetlights out, running on and off repeatedly. Ameren notified and repaired. The inlets cleaned. No dead animals reported.

Trustee Wendling reported there were no complaints.

Chairman Bornmueller reported 2 housing inspections completed, 1 fence permit issued, 1 zoning approval, 28 business license renewals.

Attorney Report:

Police Report:

Officer Brannan presented a summary of police activity for June 2023: Total calls for services-688. There were 160 directed calls-, self-initiated calls- 528, reports written-31, citations/warnings 18/88, summonses issued-2, drug/DWI-1/1, total arrests-11. Larceny-6, burglary-0, robbery-0, assault-0, auto theft-1, fraud-1, rape -0, destruction of property-2, trespassings-3.
